### Background

Real Estate Management (UK) Limited (REM) provides end-to-end property development and asset management services to real estate investors.

The company specialises in premium London assets, such as The Shard, as part of a portfolio comprising 1.9 million sq ft of premium mixed-use lettable space and a £320 million development pipeline.

REM provides services across the full lifecycle of real estate investments, from acquisition, development and construction to leasing, marketing, asset and property management.

This integrated approach provides a seamless service that ensures maximum overall return.

### The Challenge

In an increasingly digital world, the importance of robust cybersecurity measures cannot be overstated.

REM recognised this as a priority and, backed by Wanstor's expertise, implemented a process to achieve Cyber Essentials Plus certification, a significant step in reinforcing its cybersecurity effectiveness.

Cyber Essentials is a UK governmentbacked scheme designed to fortify organisations against a range of common cyber threats.

Certification requires an external, third-party audit of five basic technical controls, ranging from firewalls, secure configuration and user access control to malware protection and patch management.

Achieving this certification is a testament to an organisation's commitment to cybersecurity and the protection of client data.



### **The Solution**

For REM, attaining Cyber Essentials Plus certification was both a compliance measure and a strategic move to enhance their cybersecurity infrastructure – part of a broader strategy moving towards more cloud-based services and business process automation to improve operational efficiency.

Wanstor's role extended beyond certification to forming an integral part of REM's IT lifecycle as an extension of their IT team, focused on both tactical upgrades and broader strategic changes in ways of working.

The certification process was enhanced by close collaboration, including knowledge sharing sessions and the integration of IT systems and communication channels including Microsoft Teams and SharePoint. The Cyber Essentials Plus certification process involved a thorough assessment of REM's existing cybersecurity measures, identifying areas for improvement and undertaking:

- An external network vulnerability scan
- An internal network vulnerability scan with patch checking
- Review of malware protection across sample devices to ensure antivirus solution updates
- Check email filters block test malware
- Check security solutions block downloads of test malware
